

PRIVACY POLICY

The Sonia Nabeta Foundation is committed to keeping confidential, secure and private any and all personal information collected from visitors and users of our website.

Collection and Use of Information

The Sonia Nabeta Foundation collects personally-identifiable information that is voluntarily provided such as your name, mailing address, email address, billing address and credit card information, which are used to complete your donation. Please rest assured that our website will only collect personally-identifiable information that you knowingly and voluntarily provide. We will use this information only for the purpose for which it is requested and any additional uses specifically provided for on our website.

The Sonia Nabeta Foundation does not now, nor will it in the future, sell, rent or lease any of your personally-identifiable information to any third parties.

Data Security

In order to make your visit to our website as safe and secure as possible, our website is monitored on a regular basis for security threats and known vulnerabilities. We also use regular Malware Scanning.

All sensitive information, including credit card information, is encrypted via Secure Socket Layer (SSL) technology. All transactions on our website are processed through a gateway provider and are neither stored nor processed on our servers.

The Sonia Nabeta Foundation is committed to maintaining adequate physical, procedural and technical security to prevent any loss, misuse, unauthorized access, disclosure or modification of your personal information.

Cookies

Our website collects non-personally identifiable information passively using “cookies”. “Cookies” are small text files that are placed on your computer in order to identify your web browser and the activities of your computer on our website and other websites.

Our website uses cookies to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

Cookies cannot retrieve any other data from a hard drive or obtain an email address. Although you have the ability to modify most browsers to either accept all cookies, notify you when a cookie is sent, or reject all cookies, some of the features on our website, including the donation functions, will not function properly without them.

Children Under the Age of 13

Anyone under the age of thirteen (13) must seek and obtain written parent or guardian permission to use our website.
